SUMMARY OF THE BOARD MEETING

Roll call – Mr. Edgard Hernandez, Pension Administrator, called the roll. The roll call reflected Trustees Moy, Taylor and Chairman Simmons were physically present. Trustees Fernandez, Jimenez, Sharpe, and Vice-Chair Lugo were present via Zoom/Remote. Trustees Graves and Torres were absent.

APPROVAL OF MINUTES:

May 26, 2023 – Trustee Taylor moved to approve. Trustee Moy seconded the motion. The motion was unanimously approved. Trustees Torres and Fernandez were absent for the motion.

FOR APPROVAL:

GESE Lump Sum Payments – Exhibit A – Mr. Hernandez stated that there were 11 refund and rollover checks in the amount of \$181,138.21 and 5 Accrued Leave Balance Transfers in the amount of \$166,334.80. There is 1 Ordinary Death Benefit check in the amount of \$7,367.28 representing partial payment to one of three beneficiaries. Mr. Hernandez asked for a motion to approve the Grand Total for Exhibit A in the amount of \$354,840.29. Some discussion took place regarding the death of the City employee Nicole Clark. Trustee Moy moved to have Mr. Silver and Mr. Schwedock review all reports and medical records regarding Nicole Clark's incident at work and death to be discussed at the next Board meeting. Trustee Taylor seconded the motion. The motion was unanimously approved. Trustee Torres was absent for the motion. Trustee Taylor moved to approve Exhibit A. Trustee Sharpe seconded the motion. The motion was unanimously approved. No other discussion took place. This report concluded.

GESE Retirements and Deaths – Exhibit B - Mr. Hernandez stated that there were twenty-seven retirement checks with a total of \$819,404.87. There are approximately 101 retirements for fiscal year until now. There were 16 demises. Fifty-one deaths year-to-date (thirty-six retirees and fifteen beneficiaries). Mr. Hernandez asked for a motion to approve the Grand Total for Exhibit B in the amount of \$819,404.87. Trustee Taylor moved to approve. Trustee Sharpe seconded the motion. The motion was unanimously approved. No other discussion took place. This report concluded.

ATTORNEY'S REPORT:

Presented by Mr. Ronald Silver

Defined Contributions Plan - Mr. Silver presented an article for the information of the Board regarding Defined Contributions Plans and all the litigation revolving them at this time.

City of Chicago Pension Plan – Mr. Silver presented an article regarding the \$35 billion crisis and the problems they are facing as far as their pension system is concerned. The City of Chicago and City of Miami pension systems are very different but for the Board to be aware of how and where these matters are being discussed.

CORPATH – Mr. Silver presented an article regarding the conference in December 2023 in Las Vegas, NV. The organization's purpose is to legitimize the existence of Defined Benefit Plans.

IFEBP Annual Conference – Mr. Silver presented a handout regarding the IFEBP annual Conference being held this October in Boston, MA.

Trustee Taylor moved to approve the report. Vice-Chair Lugo seconded the motion. The motion was unanimously approved. Trustee Torres was absent for the motion. No other discussion took place. This report concluded.

ADMINISTRATOR'S REPORT:

Presented by Mr. Edgard Hernandez

Suspension of Pension Benefit Payments – Mr. Hernandez stated that following the motion that the Board passed in 2017 and administrative rule approved in 2019, we will be suspending payments to pension recipients who have not submitted the biennial verification form. The form is posted online. We asked the Retirees Association to advise their members of the deadline. The first mailout was in April and the second mailout was in June with an August 31st deadline. Two hundred eighty-one pension recipients have not responded. We will be calling and emailing these recipients, including doing a wellness check if necessary. Mr. Hernandez stated that a percentage of the non-responders will be suspended. Some discussion took place. Trustee Taylor moved to approve the report. Trustee Moy seconded

the motion. The motion was unanimously approved. Trustee Torres was absent for the motion. No other discussion took place. This report concluded.

FASE2 C&W, LLC:

Presented by Mr. Jose Fernandez

Division 3 - Miami GESE Ordinance Update - Mr. Fernandez reported on the updates and the cleanup of the language in the City Ordinances. Three types of changes are being proposed. The first type of change is a cleanup of the Ordinances to comply with administrative practices. The second change regards compliance with an IRS requirement to update the required minimum distribution age. The third change is to update the Ordinance due to recently negotiated plan changes including those for non-union members. The first two changes have no cost impact to the plan. The third change does have a cost impact and have already been included in the actuarial impact statement. The City is aware of the cost impact and they have approved those changes. Legal counsel stated that these changes will have to go before Commission for approval. A lengthy discussion took place on several sections of the ordinance and the following are suggested edits as discussed by the Board, Sec.40-241(d) eliminating language that exempts AFSCME Council 79, Local 871 from having the average final compensation shall mean the highest one year of compensation; eliminating language in the definition of Compensation that exempts AFSCME Council 79, Local 871 and in the definition of Normal Retirement Age that exempts Local 871; adding the definition Rule of 80 Retirement. Trustee Moy suggested inviting the City Attorney to come before the Board to go over these Ordinance edits. Mr. Fernandez suggested having the City Actuary come as well. Further edits of the Ordinance include Sec.40-254(1)(d) replace the "Rule of Seventy (70)" and insert "eligibility" so that member is eligible for retirement under any retirement eligibility; Sec.40-255(a)(2)(b) eliminate language that exempts AFSCME Council 79, Local 871 from Service Retirement benefit shall be equal to three percent of the member's highest one year of compensation multiplied by the number of years of credible service, and deleting Sec.40-255(a)(4) as it no longer applies; Sec.40-255(g)(2) and Sec.40-255(g)(5) Ordinary Death Benefit, Post-Retirement Death Benefits to include language designating a spouse as beneficiary; Sec.40-255(k) Change in Beneficiary after retirement as long as there is no cost impact on the Plan; Sec.40-255(i) Deferred Retirement Option Program to state that effective September 19, 2022, the DROP of the retirement plan shall be available for

all members of the plan and shall consist of a FORWARD DROP and a BACDROP. Any general employee who has reached Normal retirement age shall be eligible to participate in the DROP, and subsection (i)(1) and (i)(2) shall read that the participation is for a maximum of 84 months; Sec.40-255(i)(14) BACKDROP option. A backdrop benefit option shall be implemented on January 1, 2013. Members eligible for the DROP and who choose not to enter the DROP remain eligible for the backdrop; Sec.40-255(n) Limitation on Benefits delete language that exempts AFSCME Council 79, Local 871 from the \$100,000 and \$80,000 maximum annual retirement allowance; Sec.40-262(d) and Sec.40-262(e)(2) updating the required minimum distribution age per Internal Revenue Code (i) age 72 for members who attain age 72 before January 1, 2023, (ii) age 73 for members who attain age 72 on and after January 1, 2023, and age 73 before January 1, 2033, and (iii) age 75 for members who attain age 74 on and after January 1, 2033 and if the member fails to elect a form of payment by the required beginning date, the retirement allowance shall be paid as single life annuity. Mr. Hernandez stated that we will summarize the changes, take away those with issues, then assign it to the legal counsel and eventually contact the City to make the necessary changes. Mr. Silver stated that the labor attorneys should contact the City to ensure the bargaining unions' negotiations are put in the Ordinances. Some discussion took place. Trustee Taylor moved to continue the review and take the necessary steps to update the ordinances. Trustee Moy seconded the motion. The motion was unanimously approved. Trustee Torres was absent for the motion. No other discussion took place. This report concluded.

SOUTHEASTERN ADVISORY SERVICES' REPORT:

Presented by Ms. Hilda Thompson and Mr. Wally Wilson

Ms. Thompson said there was nothing official but as of last night the rough draft is up \$36 million to \$922 million market value, a 4.6% return for the quarter, up 17% return for the fiscal year in just nine months. No action was taken. This report concluded.

Trustee Moy moved to adjourn. Trustee Taylor seconded the motion. The motion was unanimously approved. Trustee Torres was absent for this motion.
